DISASTER MANAGEMENT ACT, 2002: AMENDMENT OF REGULATIONS ISSUED IN TERMS OF SECTION 27(2)

I, Dr Nkosazana Dlamini Zuma, Minister of Cooperative Governance and Traditional Affairs, designated under section 3 of the Disaster Management Act, 2002 (Act No. 57 of 2002), having declared a national state of disaster published by Government Notice No. 313 of 15 March 2020, and extended by Government Notices Nos. 646 of 5 June 2020, 765 of 13 July 2020, 889 of 15 August 2020, 995 of 14 September 2020, 1090 of 14 October 2020, 1225 of 14 November 2020, No.1341 of 11 December 2020, No. R. 15 of 13 January 2021, No. R. 86 of 11 February 2021, No. R. 193 of 11 March 2021, No. 333 of 14 April 2021, No. R. 424 of 14 May 2021, No. R. 476 of 30 May 2021, No. R. 493 of 11 June 2021, No. R. 611 of 12 July 2021, No. R. 733 of 12 August 2021, No. R. 867 of 12 September 2021, No. R. 1031 of 13 October 2021, No. R. 1501 of 13 November 2021, No. R. 1598 of 10 December 2021 and No. R. 1672 of 14 January 2022, hereby in terms of section 27(2) of the Disaster Management Act, 2002, after consultation with the relevant Cabinet members, make the Regulations in the Schedule.

SCHEDULE

Definitions

1. In these Regulations, "the Regulations" means the regulations published by Government Notice No. R. 480 of 29 April 2020 as amended by Government Notices Nos. Amendment of the Classification of the Regulations

- 2. The Classification of the Regulations is hereby amended by—
- (a) the substitution of item 6 for the following item:

- "6. Refusal of treatment and isolation"; and
- (b) the substitution of item 7 for the following item:"7. Isolation of persons".

Amendment of regulation 1 of the regulations

3. Regulation 1 of the Regulations is hereby amended by the deletion of the definition **"quarantine**".

Substitution of regulation 6 of the Regulations

4. Regulation 6 of the Regulations is hereby substituted of the following regulation:

"Refusal of treatment and isolation

6. (1) No person who is a confirmed laboratory positive COVID-19 case and is symptomatic, may refuse to be treated or to be admitted to a health establishment for treatment or isolation in order to prevent transmission: Provided that if a person does not comply with the instruction or order of the enforcement officer that person must be placed in isolation at a health facility for a period not exceeding 48 hours, pending a warrant being issued by a competent Court, on application by an enforcement officer for the purposes of isolation or treatment.

(2) A warrant contemplated in subregulation (1) may be issued by a magistrate, if it appears from information on oath or affirmation by an enforcement officer that a person is a confirmed laboratory positive COVID-19 case and is symptomatic.

(3) The warrant may impose restrictions on the powers of the enforcement officer as the magistrate may deem fit.

(4) A warrant issued in terms of this regulation remains in force until-

(a) it is executed;

(b) it is rescinded by a competent court; or

(c) the purpose for the issuing of the warrant has lapsed,

whichever occurs first.".

Substitution of regulation 7 of the Regulations

5. Regulation 7 of the Regulations is hereby substituted by the following regulation:

"Isolation of persons

7. (1) Any person who is a confirmed laboratory positive COVID-19 case and is asymptomatic is not required to isolate.

(2) Any person who is a confirmed laboratory positive COVID-19 case and is symptomatic must isolate him/herself for a period of 7 days, unless a longer period is recommended by a medical practitioner.

(3) Any person who is a confirmed laboratory positive COVID-19 case and is symptomatic must comply with—

(a) an oral instruction of, or a written direction, issued by a medical practitioner, a person authorised by the medical practitioner, a nurse or an enforcement officer to subject himself or herself to isolation at a health facility in order to contain the transmission of COVID-19; or

(b) the requirements of self-isolation in order to contain the transmission of COVID-19.

(4) If a person refuses to isolate himself or herself as instructed or directed, a magistrate in whose jurisdiction such a person is, must make an order as contemplated in Form 1 of Annexure A, to compel such a person to isolate himself or herself.".

Substitution of regulation 10 of the Regulations

6. Regulation 10 of the Regulations is hereby substituted of the following regulation:

"Shelters and sites identified by the State during national state of disaster

10. (1) The State shall identify temporary shelters for homeless people that comply with the necessary health protocols and adequate spacing standards as provided for in guidelines published by the Director General of Health.

(2) The provision of the State's resources contemplated in subregulation (1) shall be for the duration of the national state of disaster, and the use thereof will be subject to conditions determined by the Cabinet member responsible for such resources.".

Amendment of regulation 66A of the Regulations

7. Regulation 66A of the Regulations is hereby amended by the substitution of paragraph (*a*) of subregulation (4) for the following paragraph:

"(a) No social distancing measures will apply in the basic education sector.".

Substitution of Form 1 of Annexure A to the Regulations

8. Form 1 of Annexure A to the Regulations is hereby substituted by the following Form:

Amendment of Annexure D to the Regulations

9. Annexure D to the Regulations is hereby amended by the deletion of item 22.

10. The amendment to Regulations will come into operation on publication in the *Gazette* except regulation *66A*, which will come into operation on 7 February 2022.
